## Gonzales man arrested for threat made to GHS

The Gonzales Police Department arrested an 18-year-old Gonzales resident in connection not only to threats that were made to Gonzales High School, but they also are

investigating possible charges related to child pornography.

Jacob Julian Reyes, 18, has been charged with a third-degree felony, terroristic threat to impair public service, place the public in fear of serious bodily injury and influence the conduct or activities of a political subdivision of the state.

He was bonded out on Friday, Feb. 16, on a \$25,000 surety bond by All About Bail Bonds of Gonzales.

According to the Texas Penal Code, a person commits a terroristic threat if he threatens to commit

any offense involving violence to any person or property with intent to:

• cause impairment or interruption of public communications, public transportation, public water,

### **GISD** hosts community

### bond meeting, selects architect, contractor

The Gonzales ISD School Board held its financial transparency meeting Monday, Feb. 19 regarding the \$50.6 million bond that was passed in November 2023.

The board had Jennifer Black from Sledge Engineering present to speak to the members of the community who wanted to ask questions.

"One of the big things that we will be doing with this bond project is making sure that not only are we reviewing everything that goes through, so invoices and all of that, but we want to make sure that the public sees it." Black said 'That's one of the reasons Gonzales ISD hired us was so that we can help make sure they're following the law, but also helping disseminate the information and oversee construction."

On the district website, a Dropbox is active so the community can see what the district is spending and see the different folders regarding the bond.

"In that Dropbox link, there will be multiple folders. And as we get moving further on the

### **Commissioners discuss creating** formal county HR department

Gonzales County commissioners will consider whether to create a separate HR department and have it fall under the umbrella of County Judge Pat Davis at an upcoming meeting.

Davis brought the issue up to the court during their Monday, Feb. 12, meeting, saying it is something he had been thinking about for some time. Currently, HR issues are handled by the same assistant who handles county payroll for County Auditor Becky Weston — Misty Cook.

"I've had numerous people, both local elected officials and employees, come to me with different scenarios to discuss because it involves an HR situation and I always seem to have handled it," Davis said. "And I just think it would be better if it was under the county judge."

Davis said he spoke to officials from several other counties at Precinct 2 Commissioner Donnie Brzozowski's request to find out who oversees their HR departments.

"Every county I spoke to except Lavaca County — I spoke to DeWitt, Karnes, Llano — all the other counties have it under the county judge," Davis said. "Only



## Master Gardeners' tomato, vegetable plant sale is March 2

With winter temperatures seemingly behind us and spring right around the corner, now is a great time to start prepping your garden beds for the planting of springtime plants and vegetables.

With that in mind and for those who enjoy vegetable gardening, think about attending the annual Gonzales Master Gardeners' Tomato & Vegetable Plant Sale.

As in year's past, the sale will be held at PACE: Plantatarium A Center for Exploration on Saturday, March 2, where once again, tomatoes, peppers and other vegetables, all started and grown by master gardener members and students, will be available for purchase.

This year, Sandy Llewellyn, the Vegetable Grow Team Leader, promises 25 varieties of tomatoes and numerous vegetable varieties all specifically selected to perform well



in this part of Texas. Of the tomato varieties, they include the popular Celebrity, Early Girl, Better Boy, and Super Sweet 100 (cherry), and of the heirloom varieties, there will be Brandywine, San Marzano, Amish Paste, Cherokee Purple, Prudent Purple, Mortgage Lifter and others.

Heirloom tomatoes are known to be more resistant to various plant diseases and insects. In addition, the starter vegetable varieties to select from will include peppers,

squash, zucchini, cucumbers, okra, and eggplant along with some watermelon and cantaloupe starter plants.

PACE is located at 623 N. Fair Street and is between the **Gonzales Elementary School** and Bus Barn. The sale will be held inside from 8:30 a.m. until 1 p.m. or until sold out, so come early for best selection. The number of people in the building will be limited at any given time and there will be helpers ready to assist with questions and information that will include a description and picture of each variety available. Cash/checks/credit/ debit cards will all be accepted forms of payment.

The proceeds from this fundraiser help support our mission of teaching the community and school children about gardening and horticulture. Gonzales Master Gardeners is a 501(c)(3) working under the direction of the Texas A&M AgriLife Extension.



Q. Our peach tree is already blooming. What happens if we skip the pruning this year?

A. You did not mention how old the tree is or its variety. A lot of the early blooming selections get pruned after they start blooming. It is best if you can prune it even if it is blooming. At least make some pruning cuts to open up the middle of the tree for air and light access. Also cut off any dead branches or branches going straight up from the joints. And of course, prune out all the suckers emerging from the root area and base of the trunk.

Q. We got behind in our mowing the rescue grass weeds on our lawn. The mower seems to be able to handle the tall blades but leaves hay like rows. Do we leave them, or can we pile the cuttings on the compost pile?

A. Yes, the weedy grasses make a great addition to the compost pile. The hay rows will eventually decompose on the lawn, but it looks much better in the compost pile.

Q. What are some of the best trees and large shrubs for producing berries for birds?

A. Consider anaqua, mulberry, Texas persimmon, standard yaupon holly, and Chinese pistache. Be alert to the fact that mulberry and Chinese pistache may spread in the landscape.

Q. We covered our whopper begonias and even though the tops froze, and they looked terrible, at least half are producing growth from the roots and base. Are they worthwhile to nurture for the next growing season?

A. Absolutely! In a few weeks give the plants with new growth a dose of Osmocote after you carefully cut off the remnants of the dead branches.



## Gone to Gonzales and the Alamo: One family's story

He was standing there in the cabin, trying to remember where his other powder pouch was. He also wanted to make sure he had his extra knife. And the pistol.

"Do not forget the pistol," he said to himself. He had plenty of time no need to rush.

The men were going to assemble on the square in Gonzales this afternoon and leave from there for the Alamo. The letter from Colonel Travis had arrived in Gonzales yesterday from the Alamo. The letter stated there was a large enemy force in sight. Travis also said that he only had 150 men, but was determined to defend the Alamo to the last. The word had gone out from Gonzales, and now men were volunteering to go help Travis at the Alamo.

His daughter came into the cabin, and noticed his preparations. This curly haired six-year-old was their only child.

"Where are you going, Daddy?" she said in that beautiful sing-song voice that children possess.

"Well, baby girl, Daddy has to go on a trip to take care of some business," he said, his voice cracking a little bit.


project and have different projects, named on what they are, you'll see more folders pop in there, but you'll see everything from invoices that have been approved to schedules as we get them, you will see vendor contracts. So as we actually ink the contract with any particular vendor, architect, contractor geotechnical testing, whatever we're using, you'll see all of that in there as we move forward," Black said.

Sledge Engineering's mission and scope of work with Region 13 is rate projects, making ure they are reasonable accountable, transparent and efficient. Black said.

"That is everything you need to make your project come in on time and under budget. And that's what we pride ourselves in — helping the districts to manage their projects well enough that you're getting them done, that you should have the right expectations," Black added.

As Sledge works with the district's selected architect, then everything in the project will be more defined, Black said.

"This will break out into more defined projects. Instead of just seeing basically three projects here, you're going to start seeing the little projects under each one. Lavaca County had it under the auditor's office."

Precinct 3 Commissioner Kevin La Fleur said the county "cannot take a person out of the auditor's office."

"The way this thing is on the agenda, it's impossible," La Fleur said. "It would be up to the disand sets that position's budget)."

Davis said Cook should not be responsible for both duties and "we need a solid HR position in Gonzales County and not a whole bunch of people looking over it."

'We need to have one person that is already

**County Attorney Paul** Watkins chimed in and said he believes there is "an inherent conflict" in having the same person handle payroll and HR.

"Not that Becky would ever do anything wrong - I'm not suggesting that at all," Watkins said. "I'm just saying that when an HR person is responsible for the employees, and to the elected officials, but also is in charge of the money — that's an inherent conflict. "We have more than enough employees for a full time HR. That's an absolute truth. I'm going to tell you that I have had employees from this county come to me and tell me they're not comfortable going into the auditor's office to talk to HR. I think there's a conflict here, because at some point, you're going to be deciding between money and people. And that's what an HR person does - they advocate for our employees. "They will answer to somebody in the sense that they're not an elected official, and they're responsible to the commissioners court. But at the same time, they have to be an independent office," Watkins said. Davis said there is a lot more things HR could be doing for the employees, like having meetings to explain benefits for the employees. "I've got people that come to me and say they're not comfortable going to HR now," Davis added. "They're not comfortable because they don't want to say something and then it's doesn't seem to be confidential." Weston asked that the court wait until after March 1 as Cook will be helping her when the outside auditors come to audit the county and the files she has would be needed as part of the audit. The court agreed and made a motion to wait until after March 1 to determine what to do about the department.

and Judge Old approves of it, that could be done at budget time.

Weston explained that, as auditor, she is appointed by the district judge while Cook is hired by her to a position that was appointed in her budget by the judge.

"I've always had that position," Weston said. 'Whether I've had payroll (in her department) or not, I had that position. I can take payroll. We do not have a formal HR department. We've never had a formal HR department."

Weston said her recommendation is that if the court was going to create a formal HR department, "I recommend you do it during budget, because it's best time to budget for any department."

"In my office, (Cook) is an assistant auditor," Weston said. "If I plan to give payroll to someone else next week, I could - they're all assistant auditors underneath me. You asked us to take (payroll) back years ago and I gladly said yes, that we would work with you. If there's an issue, I'd like to know about it.

"If you are planning on moving forward with a formal HR department and I'm not disagreeing that you need one - you need to create a department. You need time to organize where the files are going to be kept, the training, a person who has the knowledge and where you're going to house this position."

Davis said he would not want to move payroll from the auditor's office, just the HR position, and said the two would obviously work closely together due to overlapping concerns.

torical, educational demonstrations. A reception and tours of the Edwards School Gym will take place beginning at 3:30 p.m.

The Edwards School Gym was built in 1950 at a cost of \$59,000 and includes eight classroom spaces while also doubling as an auditorium. The gym features a historic and architecturally significant lamella roof system.

The lamella roof system was devised in 1908 in Dessau, Germany, by Frederich Zollinger, the city architect. Lamellae are the vertical membranes you see when you examine the underside of a mushroom. They also form the chambers in the shell of a univalve mollusk. These very lightweight pieces support the membrane which protects the plant/animal.

In the Lamella roof system, the wood members themselves are called lamellas. The individual pieces are joined together with bolts and/or plates to form intersecting transverse arches that create a rhomboid pattern. The sheathing covering these pieces completes the structure. These roofs were especially popular between World War I and World War II when metal was in short supply.



After a twenty year exercise and healthy eating layoff from my late thirties to my late fifties. due to work, family responsibilities, and a myriad of other well thought out excuses, it was time to start using a dumbbell instead of being one. So, off to Academy Sports I went. While you can do bodyweight exercises with no special equipment (chair yoga being the newest fad), you can also use bikes, treadmills, bands, cables, balls, tires, ropes and chains, old people, Dallas Cowboy cheerleaders (if they'll cooperate), or any other form of resistance you can get your hands on. The important thing is to just get started, and be willing to invest a little time and energy into your own well being, and figuring out what will work best for you. Besides getting started, the most important factor is being somewhat consistent over a period of time, a little here and there can make a world of difference. Next week I'll share what equipment I currently use, so stay tuned.





"Oh, that is so much love," she responded, hugging his neck.

"And I'll tell you what else." "What else?" she said excitedly.

"I love you for every tree on our property. In fact, I love you for every tree in the world."

"Oh, Daddy, you are so silly." "Baby girl, I hope you always remember this day."

"I will, Daddy. You are so silly about those trees."

He kissed her cheek one last time and headed across the yard to the pens, where his wife was waiting by the horse. They had stayed awake most of the night, talking and crying. They had said, "This was not what we planned when we came to Texas, was it?"

She shook her head, no, not able to speak.

He said, "You know how much I love you."

She nodded, tears filling her eyes, knowing her words could not change his mind. She finally was able to speak.

"I will look for you on the other side."

Her words startled him at first, and then he understood. He said, "Yes, do that. I will be waiting."

## Former Apaches remember legendary Coach Vernon Hill

The Gonzales Apaches basketball program is mourning the loss of a legend and former coach in late January.

Former Apaches head basketball coach Vernon Charles Hill passed away at the age of 84 on Monday, Jan. 29 in his Carencro, La., home.

Hill led the Apaches to their only state title in 1974 — 50 years ago this March 2; the title banner hangs in the high school's old gym. He was honored as the State Coach of the Year for that 1973-74 season.

Former players spoke highly of Hill and his impact to the team and program.

"I was honored to be asked to interview regarding the recent passing of the legendary basketball coach, Vernon Hill," said former Apache Jimmy Jackson. "Under his leadership, in 1974, he led the Gonzales Apaches to the only state basketball championship in the school's history. He taught his players the value of team above self, ever striving for personal best, self-discipline and humility. Coach Hill regarded every player as his 'favorite' and took special interest in developing the skills of his players.

"It was so special for me to have the opportunity of seeing Coach Hill again in 2019 when

Lester added that she was proud of her team's performance against Luling and know they have her back and make great plays.





gas, or power supply or other public service;

 place the public or a substantial group of the public in fear of serious bodily injury; or

• influence the conduct or activities of a branch or agency of the federal government, the state, or a political subdivision of the state.

Instead of being a misdemeanor offense, if these conditions are met, the charges are upgraded to a thirddegree felony.

The threat allegedly made by Reyes was sent out via phone call to the school at 11:15 p.m. Wednesday, Feb. 14, according to the high school on Facebook. Gonzales Police Lt. Jason Montoya said Reyes allegedly made "threats/comments about shooting up the Gonzales High School and possibly being in possession of child pornography."

Montoya said the report by school officials launched an investigation of Reyes, which led to obtaining a search warrant for Reyes' residence as well as a third-degree felony arrest warrant. Reyes was arrested at 4:15 a.m. Thursday, Feb. 15 and booked into the Gonzales County Jail.

The search warrant was executed by GPD, Gonzales County Sheriff's Office and the Gonzales ISD Police Department at about 2:43 p.m. Thursday, Feb. 15, and officers took possession of multiple firearms and narcotics located in the residence.

"An ongoing investigation is being conducted regarding the allegations of possession of child pornography," Montoya said.

In addition to incumbent Councilmember Peggy Blackmon, others who filed for a seat are Mike Harris, Margie Olmos Benitez, Eric Mahler, Connie S. Blackwell and Sandra K. Dickerson. One seat has remained vacant since the death of Councilmember Sam Ramirez.

#### **NIXON CITY**

Smith and Jessica Smith. Incumbent Maggie Gaytan also did not seek reelection.

#### SMILEY CITY

There will be a rematch of the 2022 Smiley mayoral race, just with the same people in different roles. Incumbent Mayor Elizabeth "Lisa" Benavidez will be challenged by Michael Mills. In 2022, Mills was the mayor and was challenged by Benavidez in a very close election.

There are two at-large seats available on the Smiley City Council. Incumbents Ellis Villasana and Melva Childress have filed for re-election and will also see challenges from Michaela Mills and Elisa Douglass.

#### **GONZALES ISD**

Incumbent District 4 Gonzales ISD Trustee Josie Smith-Wright has filed for re-election and will be challenged by David Schautteet. Her counterpart in District 7, Trustee Sandra Gorden, will face Naomi Brown on the ballot.

#### WAELDER ISD

Three spots are available at-large on the Waelder ISD Board of Trustees. Filing to run are incumbent Trustee Adolph Gonzales, incumbent Trustee Jo Ann Ibarra, Donna Brown, Danna Kincaid and Don Kincaid.

#### **NIXON-SMILEY CISD**

Nixon-Smiley Consolidated ISD will not need to have an election this year after the only ones to file for a

#### sioner, what can be done to better maintain and improve our county roads? Is paving more of them an option?

Janota: Well, I don't know if paving them would be an option with this heavy equipment. It tears up all the pavement that you do put down, so I would imagine limestone is more cost effective, because you can grade it. If you put your pavement down, this big heavy equipment will tear it up and you've got to fill pothole after pothole after pothole. As far as getting control of that, you just have to have your commissioners go out or get hold of your law enforcement in order to track some of these large equipment operators and get them to file permits and fine them if they're way overweight.

Matias: Yes, there is a lot of traffic through parts of Gonzales County in Precinct 1, Precinct 4 and Precinct 2 as well. Yes, your roads are designed and built by base on limestone. And yes, they do sustain a lot of traffic — the weight's a big troublemaker there. Basically, if you've got oil wells on your county roads, you can get with the commissioners and county judge to keep certain traffic off certain roads, but then there's a lot of wells on a lot of county roads, and they do need access to these wells. If you go to paving these roads, you're looking at \$100,000 a mile and that's not even your correct amount of base put on the road, so your taxes would go up if you pave all these roads in the county and you wouldn't be able to afford live in this county.

Mills: I'm definitely for paving more roads, but I do not want to pass that cost to the taxpayers. There's other ways to do it. I've reached out and I've talked to commissioners in other counties. Specifically, DeWitt County has made a deal with some of the major oil corporations and they've done some cost sharing and some matching that made up to 85 cents on the dollar for some of these roads. If you get out and hustle and see what grants you can find available, I think a lot of that is communication with your other commissioners and with your judge. I'd also like to hold some of these underground water guys like Schertz-Cibolo or Canyon Regional that are running up and down our roads, tearing them up they make plenty of money off our water. I think they can pave some roads too.

The deterioration of the Gonzales County Annex Building on Sarah DeWitt Drive appears to be worse than originally thought. Do you support repairing the current building, demolishing it and building a new structure on the same site, finding an existing building to buy or building a new building elsewhere and how should the county pay for your choice?

**Matias:** At this time they are looking into engineers and contractors to see what can be done. Can we remodel it

as always, you want to try to keep it from being on the taxpayer.

Janota: I think it would come down to what the engineers think would be best. Repairing the building could be \$7 million; a new building could be \$8 million. So you would have to decide what the taxpayers — ask them what they want to do. Do they want to have a brand new building versus the old building? You just have to wait for the engineers to come up with the correct price to build you one or remodel it. The problem with finding a place to build a new one is you'd have to find some land in order to do that. I don't believe the taxpayers want to buy another piece of property and have this one vacant.


Gonzales County is working on updating its subdivision ordinance for the first time in nearly 12 years. There are concerns about how development is allowed to take place within Gonzales County, especially when it comes to making sure there is enough water to handle everyone's needs. What changes would you like to see made in the subdivision ordinance?

Mills: As we know, Caldwell County is being taken over. The county wasn't ready for the growth that they've experienced and it's coming our way. I think they're kind of jumping Luling and going straight into the Waelder and Harwood area on their way down. I think when you refer specifically to water, I think it comes down to contractor responsibility. I think that anytime a contractor comes in and wants to get a plat approved for a subdivision, I think that there should be someone to go out and ensure that there's enough water to support it. If there's not enough water to support it, I believe that the contractor should have to upgrade the county main lines. It's not fair to the people that have had meters in place for years that are struggling to get the amount of water that they need. Let the contractor pay for it and that will pass the cost on to the new homeowners that are buying the property, which will most likely mean more expensive homes, which do create more tax revenue for the county.

Janota: In order to make a beautiful subdivision, I believe your roads need to be paved in a subdivision. The subdivision needs to have their own rules as far as breaking down how many acres per lot. I believe you have to have an acre and a half per lot. You'd have to have a septic tank. Personal wells are going to be probably out of the question because you probably would be working with smaller lots. You cannot have a septic tank and your water well within 50 feet or 150 feet (of each other). I believe the Gonzales County commissioners might have to make another position for an inspector. The Emergency Management Director, Mr. Harless, may be starting to get overburdened with everything that he does, and I believe that the county might need to look at an inspector. Matias: On the subdivision ordinance, I would definitely say make the lots larger so you're not on top of each other. Water wells where everybody can have their own water well, because a lot of areas you don't have rural water. Maybe put up a storage tank and wherever the subdivision is, say it's 50 acres, put up a large storage tank so there would be plentiful water. As far as the septics yes, we've got our emergency management coordinator, you know, he does the inspections on all that. Of course, you know, there's more in subdivisions so you'll need another inspector out there. Maybe there needs to be some rules about how the subdivisions are kept clean and mowed and all that so they don't get grown up.

Incumbent City Councilmember Ellie Dominguez is running unopposed for mayor as incumbent Dorothy Riojas did not seek another term. Two at-large seats are available on the Nixon City Council, including the one belonging to Dominguez. Filing to run were Jack Rogers, Shannon place on the ballot were incumbents Place 2 Trustee Bud Box and Place 3 Trustee Richard Lott.

The last day to register to vote in the May 4 election is Thursday, April 4. Early voting begins Monday, April 22 and continues through Tuesday, April 30.



where it's at? Do we need to tear it down and rebuild? Yes, there's going to be a cost either way. If you bought another building, then you got a building sitting there and you cannot just leave it sitting there — it's a danger to the public. As far as building a new building, we are waiting for contractors and engineers to see what the cost is going to be. And yes, it would be a cost on the taxpayers from what I want to understand.

Mills: That building is definitely gonna be a major issue for the commissioners to face. I do think that something has to be done and I think the question is, "Do you want to fix it for today or do you want to invest in it for tomorrow?" I think that we could patch it, repair it and it would work for a few years. The reality is we're struggling for office space as it is. I think you might as well go ahead and figure out what is best by looking at, you know, cost efficient options, whether you go to a two-story building, whether you remodel it to the max, I think at the end of the day, it does come down to dollars and cents, you know, both money and common sense as well. And, you know,

#### PRECINCT 1 COMMISSIONER

Anton W. "Tony" Matias has raised the most money of any of the commissioner candidates, collecting \$11,280.48 in contributions since September 2023. That includes separate \$5,000 and \$2,500 contributions from Attoyac Energy Service LLC of Gonzales; \$2,000 from Texas Benefit Solutions Inc. of Gonzales; \$1,000 from Come and Take It LLC of Gonzales; \$500 from Eddie & Jody Callendar and \$50 from Richard Yates.

Matias' expenses from September 2023 through Feb. 5 are a combined \$9,924.67, which includes \$7,696.73 to N&B Signs New Braunfels for advertising; \$399.50 to HEB for travel and fuel; \$98.21 to HEB and Walmart for printing supplies; \$563.10 to Coastal Office Supply for advertising supplies; \$150 to Shelton Designs for T-shirts; \$23.52 to Garcia's of Seguin for food; \$61.95 to GG Steak House of Gonzales for food; \$750 to Gonzales County Republican Party for a filing fee; \$6.50 to Family Dollar for supplies; \$15 to Harbor Freight for advertising supplies; \$5.01 to USPS for postage; \$92.01 to Coastal Office Supply for advertising supplies and \$63.14 to Coastal Office Supply for advertising supplies.

David A. Janota reportedly has raised \$2,000.04 in political contributions since September 2023. That includes \$1,000 from David Janota; \$300 from Ludmila Janota of Gonzales; \$100 from Tyler Janota of Segun; \$100 from Melda Rios of Banquete; and \$100 from Kaleigh Walker of Mason. Expenditures for Janota were \$1,997.75, but there was not an itemized breakdown of expenses available on the campaign finance report.

Ryan Mills reported receiving \$2,950 in political contributions since September 2023. This includes \$1,800 from Joe Dale and Desiree Mills of Gonzales; \$500 from the Schroeder Family Operating Fund LLC of Gonzales; \$300 from Wayne Brown of Gonzales; \$250 form Mata Turf c/o Anthony Bevis of Shiner; and \$100 from Judy Wehde of Gonzales.

Mills reported a total of \$1,716.90 in political expenditures from campaign funds as well as \$4,341.83 in political expenditures made from personal funds. This includes \$1,716.90 to Thomas Graphics for advertising (mail out letter) as well as \$283.30 to 4imprint for pens (advertising) out of personal funds and \$4,058.53 to Personal Impressions of Gonzales out of personal funds for advertising supplies and expenses.

#### PRECINCT 3 COMMISSIONER

Roy Staton reported political contributions of \$1,450 since September 2023, including \$500 from Richard L. Kotwig of Gonzales; \$500 from Rebecca & Martin Swayze of Seguin; \$250 from Kevin La Fleur of Gonzales; and \$200 from John J. Pickens of Austin. He also reported personal contributions of \$690.44 for political expenditures.


